

## General terms of use and conditions

All information in the site has been transloaded by third parties and does not constitute offers of **worldpetmarket.com**, which therefore is not responsible for its content. **worldpetmarket.com** is not responsible for the accuracy and legality of the information the clients post.

The entry of an announcement presupposes a verified registration has taken place in the specific registration form on the site.

All interested parties can post announcements through prearranged patterns freely or by creating an account in advance, perfectly free of charge. Creating an account helps out the user with the best management of proceedings on the various services the site offers. The user is able to modify the components of his announcement for as long as it's posted.
